Home rule city with council-manager form of government. Council meets at 6:00pm Tuesdays at City Hall, 300 LaPorte Avenue. 1st and 3rd are regular sessions; 2nd and 4th are work sessions. The nonpartisan council is elected by district for four-year terms in odd-numbered years on first Tuesday following the first Monday in April. Three council members and the mayor, who is elected for a two-year term, are elected each biennial election.
